This Standard Procurement Document (SPD) has been prepared by the World Bank for Initial Selection of Applicants for the Request for Proposals (RFP) for procurement of Works & Operation Service (Design, Build and Operations for Water and Wastewater Treatment Plants. This SPD is applicable to the procurement of Works & Operation Service (Design, Build and Operate) for water and wastewater treatment plants with IBRD or IDA financing whose Legal Agreement makes reference to the *Procurement Regulations for IPF Borrowers*.
