Adesina, Akinwumi - Ph.D., President of the African Development Bank Group



Dr. Akinwumi Ayodeji Adesina is President of the African Development Bank Group since September, 2015. He is celebrated as one of Africa's leading development entrepreneurs based on his ability to develop and successfully execute bold initiatives that transform the lives of millions of people.

Before becoming President of the Bank, he was Minister of Agriculture in Nigeria, a position he has held since 2011. A bold reformer, as Minister, he turned the agriculture sector of Nigeria around within four years. Under his leadership, Nigeria's food production expanded by 21 million metric tonnes,

surpassing the 20 million metric tonnes target set out at the start of his tenure.

A consummate and highly effective builder of strategic partnerships, Dr. Adesina has worked effectively across several sectors of the African economy to lift millions of people out of poverty. He was Vice President (policy and partnerships) of the Alliance for a Green Revolution in Africa (AGRA) and served as Associate Director and Regional Director for the Southern Africa Office at the Rockefeller Foundation, for over a decade.

A prolific writer, Dr. Adesina has written over 70 scholarly publications on policy, agricultural development, and African development issues. He also served as President of the African Association of Agricultural Economists and on Editorial Boards of several academic journals He is the recipient of prestigious awards for outstanding achievements, including the YARA Prize and Forbes Africa Person of the Year Award in 2013.

Alter, Rolf - Director for Public Governance and Territorial Development, OECD



Mr. Rolf Alter is Director for Public Governance and Territorial Development of the Organisation for Economic Co-operation and Development (OECD) in Paris. He leads a team of 230 staff to support governments in improving their public sector performance for inclusive growth and the competitiveness of Key areas include institutional reform, innovation, their economies. transparency and integrity in the public sector, results-oriented budgeting, regulatory reform, and the economics of regions and cities. Under his leadership, the Directorate pursues a programme of co-operation with a wide range of non-member countries and is engaged with international institutions to advance the research on empirical evidence and good policy practices of

public sector economics and governance.

Previously, Mr. Alter was Chief of Staff of OECD Secretary-General Mr. Angel Gurría. He joined the OECD in 1991. Throughout his career with OECD he held different positions in the Economics Department, Department of Financial, Fiscal and Enterprise Affairs, and the Office of the Executive Director of the OECD.

Prior to joining the OECD, Mr. Alter was an economist in the International Monetary Fund, in Washington D.C. He started his professional career in 1981 in the German Ministry of Economy. He is currently a member of the Advisory Group of the WEF Global Risks Report. In 2015, he joined the UN High Level Panel on Water. In 2016, Mr. Alter was awarded the O.P. Dwivedi Award by IASIA.

Mr. Alter holds a doctorate degree from the University of Goettingen, Germany, following postgraduate work in Germany and the United States.

Jane Ambachtsheer is a Partner and Chair of Mercer's Global Responsible Investment Business. She is responsible for overseeing the group's strategy, developing intellectual capital across a range of responsible investment topics, and advising investors in Europe and North America.

Jane was consultant to the United Nations through the development of the Principles for Responsible Investment (PRI), which are now supported by nearly 1700 signatories. Jane is a member of the FSB Task Force on Climate-related Financial Disclosures (TCFD), a Trustee of CDP, and a member of the PRI

Academic Working Group.

Jane continues to produce new research and has been the author or co-author on a number of important papers and reports, including Mercer's Investing in a Time of Climate Change (2015). In 2011, Jane received a Lifetime Achievement Award from the Canadian Social Investment Organisation. In 2014, she was named one of Canada's 'Clean 50' leaders in the field of sustainable capitalism.

Jane is an Honorary Research Associate at Oxford University's Smith School of Enterprise and the Environment and an Adjunct Professor at the University of Toronto. She holds a Bachelor of Economics and English literature with honours from York University and a Master of Social Science from the University of Amsterdam. Jane lives in Paris with her husband and two daughters.

'Digital Bangladesh' ICT activities of Bangladesh enabled him to lead Bangladesh Civil Service in Administrative reform of reducing time, cost and visit (TCV) while providing service to the citizens. He initiated several administrative reforms including Annual Performance Appraisal (APA) system in Bangladesh Civil Service.

Mr. Azad worked for a long time for management of foreign investment, foreign grant and bilateral and multilateral investment dialogue while working in Economic Relations Division of the Government. His able negotiation skill helps successful dealings of dozens high value agreements. Mr. Azad worked for a long time in infrastructure of Power and Energy in Bangladesh. His team work and sincere efforts enable Bangladesh increasing its power generation capacity three times in a span of four years. His 34 years civil service career is enriched with field level development administration, Judicial Service, human resource development activities in different training institute. Besides civil service he gathered long experience working with private sector as chairman and director of several power and energy companies, banking and non-banking financial institute, sports and aviation.

From his childhood he is involved with scouting. He leads 1.5 million scouts in Bangladesh from the front as Chief National Commissioner of Bangladesh Scouts. He obtained an L.L.B degree in 1981 from the University of Dhaka in the department of Law.

She is also a member of the World Economic Forum's Global Agenda Council. Zeinab is a former trustee of the National Portrait Gallery. She has been a board member of the British Council, the Centre for Contemporary British History, a former Chair of the London based freedom of speech campaign organization, Article 19, and a board member of the Overseas Development Institute.

Bhattacharya, Amar - Senior Fellow Global Economy and Development Program, Brookings Institution



Amar Bhattacharya is senior fellow at the Global Economy and Development Program at Brookings Institution. His focus areas are the global economy, development finance, global governance, and the links between climate and development.

From April 2007 until September 2014 he was Director of the Group of 24, an intergovernmental group of developing country Finance Ministers and Central Bank Governors. In that capacity he led the work program of the Group, supported the deliberations of the Ministers, and was the principal point of

interface with other organizations including the G20. He has therefore been an active participant in the global economic discussions and a key representative of the views of developing countries.

Prior to taking up his position with the G24, Mr. Bhattacharya had a long-standing career in the World Bank. His last position was as Senior Advisor and Head of the International Policy and Partnership Group. In this capacity, he was the focal point for the Bank's engagement with key international groupings and institutions such as the G7/G8, G20, IMF, OECD and the Commonwealth Secretariat.

Through these different positions Mr. Bhattacharya has had a long standing engagement in research and policy discussions on the global economy and spillovers, international financial architecture, development financing and the global governance agenda including on the role and reform of the international financial institutions. He completed his undergraduate studies at the University of Delhi and Brandeis University and his graduate education at Princeton University.

Byanyima, Winnie - Executive Director of Oxfam International

Ms. Winnie Byanyima is the Executive Director of Oxfam International since May 1 2013 with a five-year term. She is a leader on women's rights, democratic governance and peace building. She served eleven years in the Ugandan Parliament, and has served at the African Union Commission and as Director of Gender and Development at the United Nations Development Program. She co-founded the 60-member Global Gender and Climate Alliance and chaired a UN task force on gender aspects of the Millennium Development Goals, and on climate change.

Born in Uganda, Ms. Byanyima was elected for three terms and served eleven years in the Ugandan Parliament. She led Uganda's first parliamentary women's caucus, championing gender equality provisions in the county's 1995 post-conflict constitution. She also founded the civil society organization Forum for Women in Democracy (FOWODE). She has served at the African Union Commission and as Director of Gender and Development at the United Nations Development Program.

Ms. Byanyima is a signatory to her country's 1985 peace agreement and has helped to broker and support women's participation in peace processes in Rwanda, South Africa, Burundi, Sudan and other countries emerging from conflict.

She co-founded a 60-member Global Gender and Climate Alliance of civil society, bilateral and multilateral organizations and chaired a UN-wide task force on gender aspects of the Millennium Development Goals, and on climate change. She has served on numerous global boards and commissions including the African Capacity Building Foundation and the International Centre for Research on Women.

She holds a M.Sc. in Mechanical Engineering in Energy Conservation and the Environment (University of Cranfield), and a B.Sc. in Aeronautical Engineering (University of Manchester).

Sir Chakrabarti, Suma - President of the European Bank for Reconstruction and Development



Sir Suma Chakrabarti is the sixth President of the European Bank for Reconstruction and Development. He assumed the presidency of EBRD in May, 2012. He has extensive experience in international development economics and policymaking, as well as in designing and implementing wider public service reform.

Most recently he held the position of Permanent Secretary at the British Ministry of Justice and was its most senior civil servant. Prior to this, from 2002, he headed the UK's Department for International Development where he worked

closely with economies undergoing substantial reform in Eastern Europe, the former Soviet Union, and the Middle East and North Africa. Sir Suma played a key role in developing the UK's successful Know-How Fund for Central and Eastern Europe and worked with the European Commission in improving its programs in the Middle East and North Africa.

Sir Suma also worked in the late 1990s in the UK Treasury, where he was responsible for public expenditure, and in the early 2000s in the Cabinet Office, where he led cross-departmental strategic issues and subsequently the management of the Cabinet agenda.

Heathcote, Chris - CEO, Global Infrastructure Hub



Chris Heathcote was appointed CEO of the Global Infrastructure Hub in June 2015. Chris brings a wealth of knowledge in infrastructure, developed through extensive experience in both the public and private sector.

Previously, Chris was a Director of Macquarie Infrastructure and Real Assets in the United Kingdom. His additional, recent, private sector experience includes positions held with WestLB AG and Lloyds Banking Group. During his time with these companies, Chris was involved in infrastructure projects in the United States, Europe, Turkey, China, the Ivory Coast and Australia.

Chris also served as head of project finance at Partnerships UK (a joint UK Treasury and privately-owned company, which promoted the Private Finance Initiative (PFI) and Public Private Partnerships (PPP)), with a focus on major infrastructure projects including the Wembley National Stadium and London Underground. He has also advised the Brazilian Government on

preparing and executing a PPP program, and co-authored of the UK Government White Paper "Meeting the Investment Challenge" while working in the UK Treasury. Chris also structured major road projects in Israel and South Africa.

Chris was also a founding partner of Hyder Infrastructure Investors in the mid-1990s, one of the early infrastructure equity funds. The fund was involved in financing of projects including Melbourne City Link, the Asian Infrastructure Fund and many United Kingdom public infrastructure projects funded with private capital.

Hoyer, Werner, Ph.D. - President of the European Investment Bank



Born 1951 in Wuppertal (Germany), Dr Werner Hoyer has a PhD in economics from the Cologne University. He started his career as a senior research assistant at the Cologne University and soon became an associate lecturer in international economic relations.

In 1985 he took on the position as Director of the Economics and Information Department of the Carl Duisberg Society, Cologne and 1987 became a Member of the German Bundestag where he stayed until 31 December 2011. During his service at the German Bundestag he held several positions; first as Whip and Security Policy Spokesman of the FDP (Free Democratic Party) Parliamentary

Group, Deputy Chairman of the German-American Parliamentary Friendship Group and Secretary General of the FDP, before becoming Minister of State at the Foreign Office.

In 2000 he became the President of the European Liberal Democratic Reform Party (ELDR), Brussels and also held the position as Deputy Chairman and Foreign Affairs Spokesman of the FDP parliamentary group. From 1994 to 1998 and then again from 1999 to 31 December 2011, he was Minister of State (Deputy Foreign Minister) at the German Foreign Office, responsible for Political and Security Affairs, European Affairs, United Nations and Arms Control and Commissioner for Franco-German Cooperation.

He is President of the European Investment Bank since 1 January 2012.

Dr Hoyer is married to Katja Hoyer, they have two children.

Kaberuka, Donald - Distinguished Visiting Fellow, CGD

Donald Kaberuka, former president of the African Development Bank Group, is a CGD distinguished visiting fellow and member of the board of directors. He is also the Hauser Leader-in-Residence at the John F. Kennedy School of Government at Harvard University.

During his tenure as president of the African Development Bank, Kaberuka bolstered its franchise value, tripled its capital from USD 30 billion to USD 100 billion, and doubled the bank's portfolio.

Kaberuka's leadership was particularly characterized by a "big push" on the private sector and leading from the front on infrastructure. He championed an inclusive growth agenda; promoted a strong link between security, development and the environment, establishing a ring-fenced facility for conflict affected countries; and appointed an international high-level panel on fragile states led by President Johnson Sirleaf of Liberia. He put in place an Africa Natural Resource Center and the African Legal Support Facility to provide support to African countries managing natural resource wealth.

Before becoming finance minister of Rwanda, Kaberuka worked in the private sector in the commodities business, including a term as chief economist of the Inter-African Coffee Organization. Kaberuka also served as governor for Rwanda for the International Monetary Fund and the World Bank from 1997 to 2005. His private interests include classical music and wildlife conservation. Kaberuka currently serves on the board of trustees of the World Economic Forum, the Mandela Institute (Minds), and the Mo Ibrahim Foundation. He is also a member of several international panels on finance and development.

Kaberuka is an alumnus of the University of Glasgow in Scotland and has been a Visiting Fellow at the Institute of Development Studies of Sussex University in England.

Julie T. Katzman is the Executive Vice President and COO of the IDB following a successful career as an investment banker.

Ms. Katzman manages the overall operations of the IDB. She has focused on driving change throughout the organization; increasing the focus on results, increasing innovation, breaking down silos, increasing diversity and inclusion, and the private sector consolidation. She also played a significant role in crafting the IDB's new capital and risk policies. She is a frequent speaker on development topics.

She serves on the Boards of the MacArthur Foundation, ICRW, the Global Banking Alliance for Women, Instituto de Empresa and the International Council on Women's Business Leaders.

Kim, Jim Yong, M.D., Ph.D. - President of the World Bank Group



Jim Yong Kim, M.D., Ph.D. is the President of the World Bank Group. Soon after he became president in July 2012, the organization established two goals: ending extreme poverty by 2030 and boosting shared prosperity for the bottom 40 percent of the population in developing countries. Kim's career has been focused on health, education, and delivering services to the poor. Before joining the World Bank, he served as President of Dartmouth College and held professorships at Harvard Medical School and the Harvard School of Public Health. From 2003-2005, as Director of the World Health Organization's HIV/AIDS Department, he led the "3 by 5" initiative, the first-ever global goal for

AIDS treatment, which helped to expand AIDS treatment in developing countries. In 1987, Kim co-founded Partners In Health, a non-profit medical organization now working in poor communities on four continents. Trained as a physician and an anthropologist, he has received several awards, including a MacArthur "Genius" Fellowship, and recognitions such as one of America's "25 Best Leaders" by U.S. News & World Report, and in 2006 TIME magazine named him as one of its "100 Most Influential People in the World."

Dr. Frannie Léautier is Senior Vice President at the African Development Bank (AfDB). She was previously Chairperson and Co-Founding Partner of Mkoba Private Equity, a fund offering growth capital to small and medium enterprises in Africa. Prior to that, she served as Vice President and Chief of Staff to the President of the World Bank; Executive Secretary of the African Capacity Building Foundation (ACBF); and Founder and Managing Partner of the Fezembat Group, a company focused on risk management and leadership development.

She has a rich executive experience including Vice Chair of the Board of PTA Bank; Treasurer and Chair of the Risk and Audit Committee of the African Economic Research Consortium (AERC): Founding Member of the Nelson Mandela Institute for Science & Technology: member of the Editorial Board of the Journal of African Trade (JAT); and Founding Member of the UONGOZI Institute. She serves on Visiting Committees at the MIT Corporation, Board of Trustees of King Baudouin Foundation USA (KBFUS), and on the Board of Trustees and Advisory Board of Women's World Banking. She is a Co-Chair of the World Economic Forum (WEF) Global Future Council on Economic Growth and Social Inclusion and is a member of the WEF Global Agenda Councils.

Dr. Léautier has a Masters and Doctorate from the Massachusetts Institute of Technology (MIT) and a Bachelor of Science in Civil Engineering from the University of Dar es Salaam, Tanzania. She graduated from Harvard University's Executive Program and holds an honorary degree in Humane Letters from North Central College in recognition of her contribution to Africa. Dr. Léautier was a Distinguished Professor at Sciences Po Paris from 2007 to 2012. She is the author of several books and articles on leadership and development.

Le Houérou, Philippe, Ph.D. - Executive Vice President and Chief Executive Officer of the International Finance Corporation



Mr. Le Houérou, a French national, joined IFC in March 2016, bringing three decades of experience in international finance and development. His career includes leadership positions at the World Bank and the European Bank for Reconstruction and Development, where he developed and implemented business strategies, helped increase lending and spearheaded new partnerships.

Prior to his arrival at IFC, Mr. Le Houérou was Vice President for Policy & Partnerships at the EBRD. In that role, he coordinated country strategies, restructured and redefined the EBRD approach to policy dialogue, and led

other initiatives to support the organization's private sector development and transition mandate. He was also responsible for the mobilization and management of donor funds for nuclear safety and for the EBRD's engagement with key external stakeholders and organizations.

Before joining the EBRD in 2015, Mr. Le Houérou was the World Bank's Regional Vice President for the South Asia Region. As Vice President, Mr. Le Houérou designed a new regional strategy, restructured the Bank's portfolio in the region to improve its performance and more than doubled new lending. He is still studying the same village and its economic and social change. He has written books on crime and the criminal statistics in the UK and a few on public finance and development. "Growth & Empowerment: Making Development Happen" was published in April 2005. The Stern Review on the Economics of Climate Change (Cambridge University Press, 2007). He has published more than 15 books and 100 articles. "A Blueprint for a Safer Planet" was published by Random House in April 2009. His most recent book is "Why are We Waiting? The Logic, Urgency, and Promise of Tackling Climate Change", published by MIT Press in May 2015.
